# SUBJECT: SUSPENSION OF TRADING IN THE SHARES OF THE COMPANY

This is with reference to your letter No.PSX/C-1082-925 dated February 19, 2018 asking to explain the reasons regarding continuation of suspension of trading in the shares of the company.

The Lahore High Court, Lahore has passed Order dated 13-07-2017 for winding up of the company in Civil Original No.43 of 2011 filed by one of the creditors. The company has, however, challenged this order before Supreme Court of Pakistan and the matter is still subjudice. Copy of Order Sheet dated 14-02-2018 is attached in support of this contention.

In the circumstances explained above, the matter of winding up is still subjudice before Supreme Court of Pakistan. Imposition of Clause 5-11-1.(m) of PSX Regulations is not attracted at this stage in this case.

This information is, therefore, requested to be placed on record.
