We write with reference to your letter No. PSX/C-112-2284 dated 10.05.2018 on the above subject.

In this regard, we are pleased that the PSX has taken notice of the speculative and harmful trading taking place with our share price. We have noted upon receiving your letter that our share price has experienced an exceptional increase during the preceding months without any significant volume. This leads us to believe that there is market manipulation occurring in the trading price of KHYT at Pakistan Stock Exchange.

In view of above, we hereby confirm to you that there has been no material information announcement regarding the Company that could have affected the market price that significantly, nor are KTM Management aware of any rumors that would affect the share price this drastically. We hereby affirm that all significant activities whether it has to do with our legal cases or our financial position are clearly disclosed in our Annual Report. In addition, we have been regularly filing with the SECP & PSX our Quarterly and Half Yearly reports which also disclose our financial position and are available to all concerned on our website: [khybertextile.com](http://khybertextile.com).

As there has been no material announcement, our Company is unable to provide you with the explanation for the significant increase in our trading price. However, we implore the PSX to look into this negative activity and take action against those individuals who are interfering with the free and fair operation of the market by manipulating our Company's share price.
