It is within your knowledge that our company has continuously been suffering heavy monetary losses for the last three years due to crises in Textile Sector and resultantly during the period of last two years several textile units had no alternate except to shut down their business activities and our company is one of them who has suspended their business activities

Presently the accumulated losses and liabilities upon the company has been exceeded from the total market value of the movable and immovable assets and properties of the company and thereby the equity value of the share is in negative.

In the prevailing circumstances the Management of the company proposed to save the interest of the minority share holders and thereby with intention to provide an opportunity to the minority share holders, the Board of Directors of the compnah has decided to buy back the share holdings of minority share holders at the rate of Rs.7/= per share upon which the last transaction was taken place.
