

We write with reference to the application dated August 05, 2019 (Copy attached) submitted in Securities & Commission of Pakistan.


We would like to inform you that our Company had been facing several issues to operate our factory situated in Uthal Balochistan. Our main problem was the continuity of power supply from K-Electric in that area and erratic fluctuations that effected our ability to have normal production. We were not able to switch to gas generation, as an alternate, since there was no gas supply in that area. Secondly, was the worsening of the security situation in that area that forced us to close our company's operation in March 2013. Due to the non-viable environment and remote location no business was being conducted except recoveries, contributions /injection of funds from directors and payment to the creditors.

As of now, we are in the process of reviving our Company and resume normal business again and we have shifted our Plant and Machinery from Uthal, Balochistan to Port Qasim in Karachi.

We would request you to kindly consider the position of our Company and we require your support as Board of Investment to help us in the revival of our company. This is also in line with the initiative of the current Government to create jobs and business activity the country.

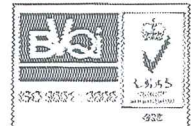

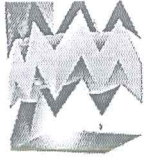
