That on 17.02.2020, the company received letter from Mr. Jam Asif Mehmood, Advocate Supreme Court, Senior Partner of LEX FIRMA, Advocates, Barristers & Legal Consultants, Karachi regarding filing of case by Mr. Anver Majid against the company bearing Suit No. 143 of 2020 along with copy of the case and stay order dated 17.02.2020. It was, inter alia, stated as follows:

ORDER SHEET 17-02-2020

Case called. Today the matter is fixed for filing C/A on behalf of the defendant # 2 as well as service on defendant # 1. Counsel for the plaintiff is present so also the counsel for defendant # 2 is present and time was fixed at 12 00 noon. Meanwhile, Mr. Muhammad Nadeem Qureshi filed Vakalatnama alongwith extract of resolution of defendant # 1 and duly received the copies of the plaint alongwith annexures and application U/O XXXIX rule 1 & 2 C.P.C. Now, the matter is taken at 12:30 pm. The plaintiff's counsel and the counsel for defendant # 1 is present while, the counsel for defendant # 2 is called absent. The plaintiff counsel Mr. Goha Mehmood Advocate argued that there is a great apprehension of conducting annual general meeting (AGM) for the year, 2020 by the defendant # 1 without notice to the plaintiff, who is the C.E.O. member, director and holding 51.328 % shares in the defendant # 1's company as per annexure P/6 but, the plaintiff is behind bar and facing J.I.T cf I'.I.A due to which the defendant # 1's company is taking advantage and conducting AGM without prior notice to the plaintiff which is the mandatory requirement as per memorandum and article of association of defendant # 1's company. Lastly, prayed the restraining order be passed against the defendant # 1 not to conduct AGM without notice to the plaintiff, who could appear through his attorney.

On the other hand, the defendant # 1 after receiving the plaint and annexures requested for grant of time for filing C/A on application U/O XXXIX rule 1 & 2 C.P.C and verbally stated that the AGM was schedule to be held in February, 2020 but no any formalities or compliances has been made by the defendant # 1 in this respect and there is no possibility of the AGM to be held in near future.

Thus, in view of the above discussion both the defendants are directed to file their C/A on application U/O XXXIX rule 1 & 2 C.P.C by the next date of hearing i.e. 25-12-2020 meanwhile, the defendant # 1 is restrained for conducting AGM till next date of hearing. However, the fate of this order shall not effect on the order passed on the application U/O XXXIX rule 1 & 2 C.P.C, which will be decided after hearing all the parties and perusing their C/A.

SUIT FOR DECLARATION AND PERMANENT INJUNCTION ALONG WITH OTHER RELIEFS

The Plaintiff respectfully submits as under:

- That the addresses of the parties have been correctly supplied in the cause title of the plaint and are sufficient for the purpose of service of process of this Hon'ble Court on them.
- 2. That the instant suit is filed by the Plaintiff through his duly constituted attorney Mr. Shams Son of Mr. Abdul Ghanl, Muslim, adult, holding CNIC No.42301-3503009-9, resident of House No.303, Tower B, Prime Residency, Civil Lines, Karachi who is competent to institute the instant suit and to do all acts necessary or incidental for proper prosecution of the case and is well conversant with the facts of the case and has signed and verified this plaint.

(Special Power of Attorney dated 20.01.2020 is attached hereto and marked as Annexure "P")

That the Defendant No. 1 is a company limited by shares and 3. was incorporated, inter alia, to buy, sell, grow, plant, cultivate or otherwise acquire sugar cane, sugar, beets, fruits, vegetables and cereals of any variety on the company's own land or on land or on lands of others, on such and conditions as the company may deem fit from time to time and advance moneys and loans to the growers, farmers, land owenres and contractors and provide them with seeds manure, machinery and or other facilities, on such terms and conditions as the company may deem fit and to consume all or any such grown owned or acquired sugar cane, sugar beet, fruits, vegetable or corn, or company's own undertakings or to dispose of supply, exporter sell all or any of these commodities to any dealers, distributors, manufactures, exporters and others on such terms and conditions as the company may deems appropriate.

(True copies of Articles of Association and Memorandum of Association of the Defendant No. 1, certificate of incorporation, Form A made upto date 24.01.2018 along with secp acknowledgment, Form 29 are attached hereto and marked as Annexure "P/1" to "P/5)

4. That the Defendant No. 2 is securities and exchanges commission of Pakistan, duly established under the SECP Act 1997, inter alia, to regulate the companies and corporate sector of the country and duty bound to perform its duties and functions as stated under said Act to safe guard interest of the members and shareholders of the companies and to ensure that that the Defendant No.1 shall follow the law but the Defendant No. 2 failed to perform the said duty.

5. That the Plaintiff is a CEO, Member, Director and holding 51.328% share holder of the Defendant No.1. Said position is reflecting through Form No. 6 submitted to the Defendant No. 2 under the Securities Act, 2015 under Section 103 (1) (b)/(c) of the said Act.

That the Plaintiff is behind the bar and facing Joint Investigation Team of FIA, Karachi.

- 7. That the Plaintiff was/is a CEO, Member, Director and majority share holder of the Defendant No. 1 hence was looking after the corporate and financial affairs of the Defendant No.1 but subsequently due the his arrest by the JIT was not able to perform his said duties and having no access to company's record and financial documents.
- 8. That under the law, Plaintiff is entitled to receive the notice of the meetings and entitled to attend the said meetings through person or through proxies and to deliberate upon each and every item of the ordinary business and special business and may take his decision accordingly. But the Defendant No. 1 miserably, illegally, unlawfully, with some ulterior motives and on the behest of some other persons, in order to deprive the Plaintiff from exercising his lawful and constitutional guaranteed fundamental rights, failed to act in accordance with law hence the Defendant No. 1 is not entitled to hold the said

AGM and approve the ordinary business and special business as

9. That the Defendant No. 2 is a regulator of the Defendant No. 1 is regulated but failed to perform its duty imposed under the law and failed 2019 /

10. That the Plaintiff have no other option but to approach this Hon'ble Court seeking declaration and permanent injunction for protection of his rights and against the illegal acts, omission and actions of the Defendant No.1.

- 11. That the cause of action arose in favor of the Plaintiff and against the Defendants on 13.01.2020, when it comes into knowledge of the Plaintiff that the Defendant is going to hold AGM for 2019/2020 and on the same day when Plaintiff approached for supply of copies of accounts and other related information but was not responded and declined and 20.01.2020 when the Plaintiff appointed its attorney and attorney also approached the Defendants but no avail and still continue to exist due to non provisions of the same and being denied status and character of the Plaintiff as lawful, legal, equitable owner of the shares in the Defendant No. 1 and on account that the Defendant No.1 is going to take unlawful, illegal, arbitrary decisions in the proposed AGM of the year 2019/2020 hence this suit before this Hon'ole Court for protection of right and interest of the Plaintiff.
- 12. That the Defendant No.1 having its main place of business of business at State Life Building No. 10, CL 5/4, Abdullah Haroon Road, Karachi and Defendant No. 2 having its main office at State Life Building No. 2, Wallace Road, off I.I. Chundrigar road, Karachi which comes under the territorial jurisdiction of Police Station Saddar at Karachi hence, under Section 20(b) of

the Code of Civil Procedure 1908, this Honorable Court has the jurisdiction to adjudicate the matter.

13. That for the purpose of Court Fee the suit is valued for One Crore Rupees wherein the maximum Court Fee of Rs. 15,000/-(Rupees Fifteen Thousand Only) is being affixed with this plaint.

PRAYER OF THE PLAINTIFF:

For the above facts and circumstances, it is respectfully prayed that this Honorable Court may graciously:

- A. Direct the Defendants to produce the members/shareholders register, Form 29 and Form A and all other statutory record, notices issued to the shareholder, members for the AGM of 2019/2020;
- B. Declare that Plaintiff is holding 51.328% shares of the Defendant No.1 and being owner of these shares fully entitled to deals these shares in accordance with law;
- C. Declare that the Plaintiff is entitled to receive and examine through proxy or duly authorized attorney the relevant books of accounts of the Defendant;
- Declare that the Plaintiff is entitled to attend all the meetings and AGM of 2019/2020 through proxy or through attorney;
- E. Declare that Defendant No.1 shall not transact the ordinary business and special business unless notices, as required under the law, shall be duly served to all the members/shareholders of the Defendant No. 1;
- F. Permanently restrain the Defendants from holding AGM of 2019/2020;
- G. Permanently restrain, the Defendants from confirming the minutes of the EOGM and Meetings and accounts of the company during pendency of the suit;
- H. In the meanwhile, restrain the Defendants from holding AGM of 2019/2020, from confirming the minutes of the EOGM and

meetings and accounts of the company, during pendency of the suit;

- Cost of the suit may graciously be awarded to Plaintiff;
- Grant any other consequential relief(s) as this Hon'ble Court may deem fit and proper in the Interest of justice.
