The brief facts for not holding the Annual General Meeting upto now are as under:

- a. Please refer to our letter no. BAL/115/2020 dated February 14,2020, BAL/125/2020 dated March 4, 2020 and your letter no EMD/233/441/2002-354 dated 9 March, 2020 sent by email and reply through our letter no. . BAL/133/2020 dated March 16,2020.
- b. We have come to know that you have already sent us the approval for holding the AGM for the year 2019 and your permission was received by someone named "Sahid". We are sorry to inform you that neither we have received any such permission nor we have anyone by the name of "Sahid in our office. You are kindly requested to send us the permission again for holding AGM for the year 2019 for 15 October, 2020 with 21 days notice time including. Please also recheck our postal address just to make sure it reaches us this time. This has never happened before. We always receive your mail. We feel that either the address mentioned on the envelope was incorrect or it reached the wrong place.

c. The Income Tax Department had frozen our Vendor's Bela Automotives Itd's bank accounts through their ORDER D.C.No. 01/40 DT 31 OCT 2014 for your reference, This matter was resolved and letter from the Income Tax Deptt. Dated 22-09-2015 informed banks that our Vendor Company's Accounts were detached, Income Tax Order No.DCIR/ENF/UNIT-05/ZONE –IV/RTO-II/2015/168 of detachment of our Vendor's Accounts.

This order of freezing of accounts by the Income Tax was certainly illegal as it had added entries of 14 years old. The said order was also illegal as he denied our Company Depreciation. The said Order was passed exparte, without giving the Company to be heard. This entire Order was illegal and it took us about one year to have the illegal add backs and depreciation to be allowed During this period, Besides monetary loss it was a loss of good will of our Company and we lost our customers.

- d. That due to carrying out of various Audit by the Government Department, the accounts of the company remained to be finalized within due time.
- e. That AGM for the year 2019 is being delayed due to some unavoidable circumstances as we were stuck up with settlement of HBL Finance Accountants, Negotiation with HBL regarding final settlement, which is still in process.
- f. That the Company is left with no other option, but apply for a direction under section 147 of the Companies Act, 2017, (direction under section 170 of the Companies Ordinance, 1984) for issuing direction in this behalf.

Under the circumstances stated above, it is requested that a direction be issued for holding the Annual General Meeting of the company permitting the company to hold its Annual General Meeting year 2019 at the 15th of October 2020.
