- 7. The Company considered new Kiln Refractory Bricks to replace the existing expired Magnesite Bricks which will arrive at factory premises in the last phase of BMR and Mechanical work but before the start of commercial production.
- 8. An equity of PKR 180 million has been injected by the management during the quarter. For the purpose of BMR, the Company will arrange PKR 2,391 million through equity and to date an amount of PKR 900 million has already been injected by the management of the Company.
- 9. Dismantling work is in process as per schedule and the contractor is being pushed to complete work according to defined timelines.

Following is the detailed breakup of undated BMR project cost which increased to PKR 5.81 billion from the initial estimated cost of PKR 3.8 billion due to the fact of additional plant & machinery along with the factors of exchange fluctuation loss, unprecedented increase in commodity prices and reimposition of sales tax.

PROGRESS REPORT - BMR

Dear Sir,

In continuation of our previous progress reports, we would like to submit the following updated progress report for the Quarter ended June 30, 2022 under section 5.11.2 (b) of PSX Regulations.

Under the BMR program, following activities are being carried out during the quarter:

- 1. The 1st shipment of plant & machinery is ready to depart from China and expected to arrive Karachi seaport in August 2022. Meanwhile, the transportation proposals are being considered to transport heavy plant & machinery from Karachi port to DCCL factory premises.
- 2. A detailed Load Flow Study has been conducted by IESCO, they recommended enhancement in sanctioned load to meet our plant requirement. However, an application for Electricity Load Enhancement has been submitted with IESCO. The process of transformer installation will begin upon arrival of transformer from China.
- 3. Zhejiang SUPCON Technology Co., Ltd.'s team visited the factory site to finalize the design and to compile all requisite data of PLC/DCS system (Programmable Logic Control / Distributed Control System).
- 4. Detailed architectural steel structure drawings completed & received from Tianjin Cement Industry Design and Research Institute Company Limited (TCDRI). Thereafter, these drawings provided to contractor to whom a contract of steel structural work has been awarded. The related activities are dependent on establishment of LCs for import of steel.
- A contract timelines are finalized for installation and operations of Solar Power Plant which
 will not only supply the cheaper and uninterrupted electricity but also reduce the dependency
 of the company on national grid.
- 6. A pre-shipment inspection activity assigned to perform examination at manufacturer's factory in China of all critical parts and machinery before being packed. Such inspection planned to be performed as per schedule of manufacturer/supplier.
