Subject: <u>Application for Extension of 30 days in Holding the Annual General Meeting and laying the Financial Statements under section 132 and 233 of the Companies Act, 2017</u>

We write with respect to the provisions of (i) Section 132(1) of the Companies Act, 2017 (the "Act"), which states, inter alia, that a company must hold an annual general meeting once at least in every calendar year within a period of 120 (one hundred twenty) days following the close of its financial year; and (ii) Section 223(1) and (2) of the Act, which states, inter alia, that the board of a company must lay before the company in an annual general meeting its financial statements, made up to a date of close of the financial year adopted by the Company, within a period of 120 (one hundred twenty) days following the close of financial year of a company.

In this respect, pursuant to the proviso to Section 132(1) of the Act and the proviso to Section 223(2) of the Act, Habib Insurance Company Limited (the "Company") hereby seeks an extension from the Commission for holding its annual general meeting and laying its financial statements for the financial year ended December 31, 2022, by period of 30 days.

For the purpose of the above, and in compliance with Regulation 27 of the Companies (General Provisions and Forms) Regulations, 2018, the following is the requisite information necessary to file an application for an extension in the period for holding an annual general meeting and laying the financial statements before such meeting:

(i) Name of Company: Habib Insurance Company Limited

- (ii) The Company's last Annual General Meeting was held on April 28, 2022, at which meeting the financial statements for the year ended December 31, 2021 were laid down for consideration of the members of the Company.
- (iii) Since the Company's financial year end on December 31, 2022, the Company's financial statements are to be laid before the members on or before April 29, 2023 (i.e within 120 (one hundred twenty) days after the close of the financial year).

(iv) Reason for Extension

This year the insurance industry has carried out the reconciliation of amounts due to/ due from other insurers/ reinsurers. Our External Auditors are performing extensive testing on the reconciling items and hence require more time to close the audit.

Resultantly, it is respectfully submitted that the financial statements of the Company should be presented to the members of the Company at an annual general meeting to be convened after the completion of the extensive testing by the Auditors.

(v) Letter from our external auditors, M/s KPMG Taseer Hadi & Co dated March 30, 2023 is also annexed.

It is therefore humbly requested that keeping in view of the circumstances, we may kindly be granted an extension for 30 days to hold the Annual General Meeting and present the audited balance sheet and profit and loss account for the year ended December 31, 2022, under section 132 and 223 of the Companies Act, 2017.


