AUDITORS CERTIFICATE IN CONNECTION WITH PAYMENT OF REDEMPTION AMOUNT TO THE NOTE HOLDERS OF ENGRO POLYMER AND CHEMICALS LIMITED SUKUK-1

We have been requested by the management of the Company to provide the Company with a certificate on the annexed 'Statement of Redemption of Rated, Secured and Privately Placed Engro Polymer and Chemicals Limited Sukuk-1 from the Central Depository System (CDS)' (the Statement), prepared by the management of the Company, which has been initialed by us for identification purposes only in connection with the payment of redemption amount to the note holders of Sukuk-1 as referred to in the 'Procedures for Revocation of CDS Eligibility of Redeemable Securities' issued by CDC (here-in-after referred to as 'the Prescribed Procedures').

Engro Polymer and Chemicals Limited (the Company) had issued 87,500 notes of Rated, Secured and Privately Placed Engro Polymer and Chemicals Limited Sukuk-1 (Sukuk-1) amounting to Rs. 100,000 each i.e. aggregate issue amount of Rs. 8,750 million, on January 11, 2019. The final book closure date from December 26, 2022 to December 28, 2022 (both days inclusive) in connection with Sukuk-1 was communicated by the Company to Central Depository Company of Pakistan Limited (CDC) through letter dated December 19, 2022. Accordingly, the aggregate redemption amount of Rs. 9,057.662 million net of withholding income tax of Rs. 3.296 million has been paid to the note holders of Sukuk-1.

Scope of Certificate

The scope of the certificate is to confirm payment of redemption amount aggregating to Rs. 9,057.662 million, net of withholding income tax of Rs. 3.296 million, on redemption of Sukuk-1 by the Company to the note holders as of January 5, 2023 after verification from the books of accounts and the bank statements of the Company.

Management Responsibility

It is the responsibility of the management of the Company to prepare the annexed Statement and provide us with the documents evidencing the compliance with the matters stated in the 'Scope of Certificate' paragraph.

Auditor's responsibility

Our responsibility is to provide a certificate in connection with the matters as stated in the 'Scope of Certificate' paragraph in accordance with 'Guidelines for Issue of Certificate for Special Purposes by Practicing Chartered Accountant Firms' issued by the Institute of Chartered Accountants of Pakistan. Our verification was limited to the procedures as mentioned below:

(i) Obtained the Statement from the management of the Company stating details of the payment of the redemption amount made by the Company to the note holders of Sukuk-1;

- (ii) Obtained the copy of the register of note holders of Sukuk-1 received by the Company from CDC as of the date of book closure and checking the mathematical accuracy of the profit calculation on the outstanding principal amount of Sukuk-1;
- (iii) Obtained details of the payment of the net redemption amount of Rs. 9,057.662 million made by the Company to the note holders of Sukuk-1 and traced the details of these payments aggregating to Rs. 9,057.662 million made from supporting documents i.e. copies of the Company's general ledger, bank statements and confirmation provided by the bank directly to us in respect of details of the note holders to whom payments were made;
- (iv) Obtained copies of the tax exemption certificates of relevant note holders of Sukuk-1 against which no income tax was withheld from the payment of redemption amount made to them by the Company; and
- (v) In relation to the income tax withheld from the relevant note holders of Sukuk-1, checked that the relevant amount has been deposited with government treasury.

Certificate

Based on the procedures mentioned above, we confirm the payment of redemption amount of Rs. 9,057.662 million net of withholding income tax therefrom aggregating to Rs. 3.296 million was made to the note holders of Sukuk-1 by the Company as of January 5, 2023.
