Further to PSX Notice No. PSX/N-1028 dated October 24, 2024 whereby, addition of non-compliance of PSX Regulation 5.11.1.(d) against the following companies due to their failure to pay the Annual Listing fee (ALF) for two (02) years, was notified for information of all concerned and PSX Notice No. PSX/N-1267 dated December 23, 2024 regarding compliance deadline:
