The Plaintiff has filed instant suit for declaration, mandatory and permanent injunction.

- 02). After admission of suit the summons/notices were issued against defendants which returned served upon defendants No.02... out of whom defendant No.02 appeared thorough his counsel and filed his objections on injunction application.
- 03). Heard learned counsel for the parties and perused the material available on record.
- passed by Hon'ble High Court of Sinch at Karachi In JCM No.51/2021 (Re. "Talal Yousaf Muhammad Najeeb)........Vs......Huffaz Seamless Industries Ltd & Others) had stayed the EOGM (Extra Ordinary General Meeting) to be held on 06.01.2022 un-till the time of rectification to show the correct share-holdings of members, while the Defendant No.02 without taking place of said process are issuing letters to Defendant No.03 for winding up the Company and if the Company would be windup then the plaintiff including other co-sharers would have to suffer from irreparable loss, therefore ad-interim injunction order may be issued to restrain the defendants from taking any corrosive measures against Plaintiff Company.

(05). On other hand defendant No.02 appearing on behalf of defendant No.02 contends that due to not holding Annual General Meeting and non-transition of annual audit financial between the last two consecutive years, it has been decided by Defendant No.02 to get which the Company through Defendant No.03 in accordance with the rules and regulation of Pakisean Stock Exchange which are statuary in nature for the public interest. However trading of share has already been suspended by Defendant No.02 and the grant of injunction would prejudice the public interest, therefore instant application may be dismissed.

The perusal of record reveals that the plaintiff has brought a prima-facie case, therefore without going into further discussion the ad-interim injunction is granted in favor of plaintiff till next date of hearing restraining the defendants from taking any corrosive measures against plaintiff company.
