# NOTICE FOR ALL MARKET PARTICIPANTS CASH SETTLED FUTURES (CSF) RELAUNCH – 1<sup>ST</sup> DEC 2025

All Market Participants including TRE Certificate Holders, Securities Brokers and other stakeholders are hereby notified that the "Cash Settled Futures (CSF)" shall Go-Live w.e.f. from Monday, December 01, 2025.

Pakistan Stock Exchange Limited (PSX) would like to take this opportunity to express its appreciation towards all TRE Certificate Holders/Securities Brokers and other stakeholders, including PSBA, for their involvement during the product development phase, and for their participation in the testing of this product.

Aiming at providing Brokers with convenience, and making market participation easier, PSX and NCCPL would like to announce following key incentives:

- 1. Waiver of CSF Trading Fee by PSX and NCCPL for the first 3 months for CSF contract period i.e. **Dec 2025, Jan 2026** and **Feb 2026**. Further, from March 01, 2026, the standard trading fee shall be applicable as per Schedule.
- 2. Waiver of Basic Deposit requirement for CSF.

Following are few key points related to CSF, that would help in smooth Go-Live operations:

- [Designated Time Schedule] (DTS) Market timing for CSF shall remain same as applicable for READY and DFC.
- [Trading & Settlement Schedule] Please refer Annexure 'A' for Trading and Settlement schedule of CSF Eligible Securities.
- [Eligible Securities] Please refer to Annexure 'B' for CSF Eligible Securities.
- [Contract Specifications] Please refer to Annexure 'C' for CSF Contract Specifications
- [JTT] TRECHs using JTT need to ensure updating the application to the latest version.
- [JTT-RMG] TRECHs using RMG of JTT may need to define policies for CSF market.
- **[OMS]** OMS clients are encouraged to ensure their system readiness.
- [KiTS] E-clear (for TOs) & other Brokers using KiTS need to define market policy to enable trading through KiTS.
- [NTT] CSF Market will be available on NTT.
