GUIDELINE FOR ONLINE

SUBSCRIPTION & PAYMENT OF RIGHTS

In line with its vision to effect customer convenience through innovation, CDC is pleased to introduce improved eLOR functionality which enables investors to make payments for LOR subscription requests online via 1BILL. IAS Account Holders can also generate right subscription requests through eAccess Portal, whereas Sub-Account holders need to get their right subscription requests generated by their respective Participant as per current practice.

The process flow for completing online right subscription requests by both IAS and Sub-Account Holders is as follows:

FOR IAS ACCOUNT HOLDERS:

SUBSCRIPTION*

- ① Login CDC ACCESS Portal and click eAccess. Add your Relationship ID and click “Manage Right Subscription” within Online Transaction
- ② Select “Add Right Subscription Request” to enter details
- ③ Upon submission, enter OTP received on your registered cell number
- ④ An auto receipt with 1BILL Payment ID will be generated for making your online payment

PAYMENT*

- ① For online payment, login internet banking and select Bill Payment option
- ② Select “1BILL Invoice/Voucher Payment” option and make payment by adding LOR code “102323” before your 1BILL Payment ID

FOR SUB-ACCOUNT HOLDERS:

- ① Contact respective Participant for generation of Right Subscription Request Receipt
- ② Participant will generate receipt and provide client copy containing 1BILL Payment ID

PAYMENT*

- ① For online payment, login internet banking and select Bill Payment option
- ② Select “1BILL Invoice/Voucher Payment” option and make payment by adding LOR code “102323” before your 1BILL Payment ID
- ③ LOR subscription will be successfully completed upon processing of payment
