This is to notify that consequent to suspension of trading in the **Ordinary Shares** (Security Symbol: **PAKCEM**) ("**Said Securities**") of Pakcem Limited ("**the Issuer**") by the Pakistan Stock Exchange Limited ("**PSX**") with effect from September 15, 2016, as notified by PSX vide notice no. PSX/N-5051 dated September 08, 2016, the Central Depository Company of Pakistan Limited has decided under Regulation 5.3.1 of the CDC Regulations to suspend the CDS Eligibility of the Said Securities of the Issuer with effect from Start of Day on September 15, 2016.
