NOTICE OF <u>EXTENSION OF SUSPENSION</u> OF CDS ELIGIBILITY OF ORDINARY SHARES OF APOLLO TEXTILE MILLS LIMITED UNDER THE CDC REGULATIONS

This is further to our notice no. CDC/LCR/227/2016 dated September 26, 2016 notifying extension of suspension of CDS Eligibility of Ordinary Shares (Security Symbol: APOT) of Apollo Textile Mills Limited (hereinafter referred to as the "Issuer") with effect from September 27, 2016 on account of failure to settle the CDC invoice in accordance with the Schedule in discharge of its obligation under the CDC Regulations.

Considering that the Issuer is continuously in default to settle the outstanding dues, Central Depository Company of Pakistan Limited has decided that the CDS Eligibility of Ordinary Shares of the Issuer shall remain suspended for a further period of another 60 Business Days commencing from December 23, 2016.

Please note that this suspension is in addition to the suspension imposed pursuant to our notice no. CDC/LCR/093/2016 dated March 29, 2016. Restoration of CDS Eligibility of Ordinary Shares of the Issuer shall be subject to removal of causes of Suspension in every respect including removal of suspension on trading by the Stock Exchange.
