SUBJECT: CHANGE OF ACCOUNTING YEAR OF THE COMPANY TO 1<sup>ST</sup> JULY TO 30<sup>TH</sup> JUNE

Dear Sir,

It was approved by the Board of Directors in their meeting held on April 22, 2015 that the accounting year of the company be changed to 1st July to 30<sup>th</sup> June every year instead of 1st January to 31<sup>st</sup> December to coincides with the holding company accounting year, subject to the approval of the Income Tax authorities and after getting necessary regulatory approvals.

We have applied for the approval of Income Tax Authorities under section 74(4) of the Income Tax Ordinance and the same is pending due to technical error in their system. A copy of the confirmation of tax consultant is attached for reference purpose. As soon as the approval is received the same will be provide to you. Subsequent to the approval the accounting year of the company will be closed on June 30, each year.

In order to remain compliant to the requirements of the Companies Ordinance 1984, the accounts for the year 1st July 2014 to June 30, 2015 will be prepared accordingly and the same will be placed before the shareholders after audit by the statutory auditors. Thus there will be an overlap of six months i.e. July 2014 to December 2014.

This is with reference to application filed on 29 May 2015 by Lafarge Pakistan Cement Limited [herein after referred as 'the Company'], in terms of section 74(4) of the Income Tax Ordinance, 2001 [the Ordinance] seeking permission of the Commissioner Inland Revenue to adopt Normal Tax Year (01 July to 30 June) as against Special Tax Year (01 January to 31 December).

We are writing to update you about status of this request. Kindly note that the Commissioner (Enforcement) at LTU Islamabad has approved the application in principle; however since approval process is now online, the application couldn't be approved due to technical errors in FBR IRIS module. In our follow up today, we have been informed by the Commissioner that she has taken up this matter with FBR and it is likely that the matter will be resolved in 2-3 days' time, where-after she will approved the application online. She also advised that the Company prepares its accounts and file return by taking 30th June as fiscal year end as there is no legal objection from the Department's side for change of tax year and that the approval is only a matter of procedure which will be done as soon as FBR modifies its online system.

This is for your information. We are following up it on daily basis and will keep you posted on further developments on this matter.
