Dear Sir,

This is with reference to section 132 & 223 of the Companies Act 2017, wherein company requires to hold Annual General Meeting of the Company within 120 days following the close of its financial year.

In this regard, this is to apprise that Audit of accounts for FY 2018-19 is in progress and the audit of the Accounts could not be completed as of today i.e. September 30, 2019 due to non-resolution of certain significant matters in the current year. Non completion of audit has necessitated this application under sections 132 & 223 of the Companies Act 2017 seeking extension for 30 days in holding the Annual General Meeting of the Company and laying of accounts therein.

The particulars required under Regulation 27 of the Companies (General Provisions and Forms) Regulations, 2018 are given hereunder:

- The last Annual General Meeting of the Shareholders of the Company was held on May 23, 2019 and Accounts for the year ended June 30, 2018 were laid therein.
- The date up to which the AGM is required to be held under the purposes of the said sections and the date up to which the balance sheet and profit and loss account and reports relating to accounts are required to laid at such meeting.

The Annual General Meeting of the Shareholders of the Company is required to be held on October 28, 2019 and the Audited Accounts for the Year ended June 30, 2019 are required to be laid down before the Shareholders.

4. Reasons for not being able to hold the AGM, or laying the balance sheet, profit & loss account at the AGM by the date mentioned in clause III and the justification for extension in the period to the extent applied for.

M/sEY Ford Rhodes. Chartered Accountants appointed as Company's statutory auditors on May 23, 2019 for the FY 2018-19. Thereafter, they have completed the review of half yearly accounts and issued report thereon on July 26, 2019. Now the Audit of accounts for FY 2018-19 is in process and the audit of the Accounts could not be completed as of today i.e. September 30, 2019. The Auditors have given the that understanding audit will completed and the audited Accounts will be submitted to the Audit Committee and the Board as well within four weeks after the decision of the Oil and Gas Regulatory Authority (OGRA) with respect the Final Revenue to Requirement of the Company. Hence extension of 30 days is sought, so that statutory notice period of 21 days along with printing process may be met after October 28, 2019, being the last date of holding AGM in normal course of business.

When the delay is attributed to non-completion of books of accounts or non-finalization of audit, the exact state of books of accounts with reasons for non-completion of such books or for non-finalization of the audit, as the case may be, such information being accompanied by a certificate of the company's auditor as to the state of its accounts, reasons for delay in completion of audit and the minimum time required for the purpose; and

6. The application shall be accompanied by a copy of the last audited balance-sheet and profit and loss account.


