Governor Sindh receives five trucks containing 3,000 ration bags

KARACHI (APP): Sindh Governor Imran Ismail, on Monday, received five trucks containing 3,000 ration bags donated by the Ministry of Maritime Affairs and the Karachi Port Trust (KPT) for the needy people of Hyderabad and labourers of Lakhra. Talking to media along with Opposition leader in Sindh Assem-



bly, MPA Firdous Shamim Nagyi, MPA Khurram Sher Zaman and Chairman KPT Rear Admiral Jameel Akhter, Sindh Governor Imran Ismail said that his target was distribution of around 50,000 ration bags among the needy, said a spokesperson to the Sindh Governor, Imran Ismail said that we have so far distributed around 7.000 ration bags while 3,000 more ration bags have reached on Monday. He said that rations bags were being distributed with the help of philanthropists and welfare organizations so that lockdown affectees could get ration on time. Imran Ismail noted that over 1.2 million people from Sindh were registered in the Tiger Force.

Coronavirus dedicated hospital established in Haripur

HARIPUR (APP): District administration and health department Haripur made operational an abandoned hospital after 12 years and established it as a coronavirus dedicated hospital. This was stated by the District Health Officer (DHO) Haripur Dr. Saifullah Khan while talking to the media during the visit to the hospital. According to the details, 12 years back the hospital was established for Dengue fever patients but did not use during the course of time and was abandoned. New SOPs underway for post lockdown life-style : Murad

Sindh Chief Minister Syed Murad Ali Shah has said that the threat of COVID-19 has completely changed our lifestyle, therefore government is preparing Standard Operation Procedures (SOPs) for each and every sector, including mosques, educational institutions, shopping centres and other areas of operation for post lockdown period.

"Now, new rules of leading day to day life are developing and in the post lockdown period the life will not be the same as it was in the first week of January 2020, therefore everyone will have to reshape his or her domestic, business, social life." He said on Monday in his video message released from the CM House, according to a spokesperson to CM Sindh.

Syed Murad Ali Shah said that his government

had engaged health experts, top government functionaries and social scientists to work out new SOPs for post lockdown period under which people would be bound down to offer prayers, to do business and lead social and domestic life. "But, it is very much clear that the life has changed and now it will be only and only be health-oriented life style," he said. Talking about COVID-19

cases, he said the tally had reached 932, of which 253 had recovered that came to 27.5 percent of the infected people and 17 patients could not survive. The CM Sindh said that the number of infected people on Sunday was 881 and 51 new cases were detected on Monday, thus the number of cases reached to 932 till Monday morning. He added that till Monday morning 9,589 tests have been conducted

Sharing good news with the people of Sindh, the chief minister said that the number of patients recovered till Monday morning was 253 which according

to him constituted 27.5 percent of the infected people. He added that at present 662 patients were under treatment in public private hospitals and 342 people were under isolation at their homes. The chief minister urged the philanthropists to distribute ration with utmost care and must maintain social distancing from the recipi-

ents. "If you [philanthropists] fail to maintain social distance from the people you are giving ration they will be infected," he warned and termed it as a crime against poor people.

He urged the people to ensure social distancing at their homes. I will urge you to keep social distancing from your elders and children because they are more prone to the threat of infection," he said and added "Your precautions will be surety of the health of your near and dear ones." The chief minister told the Coronavirus infected or suspected people that they would be receiving phone calls from government offices.

"I would request you to cooperate with them even if you receive more calls from different departments for inquiring your social contacts etc – we all are doing this for you," he said.

Additional Director General (ADG) Amer Aziz, Directors Mehr Ayub, Junaid Hasan, Asma Mohsin and other officers were also present in the

The Director General FDA said that the PM's package in construction sector was very important and significant for strengthening the economy of Pakistan in the wake of present situation and added that the construction sector allied industries would also be flourished besides overcoming the issues of unemployment with the help of PM's package. He in-

formed that under the directions of Chief Minister Sardar Usman Buzdar, the Puniab government had ordered to the development authorities for taking special initiatives for boosting up the construction sector and workable strategy would be followed by FDA to play vibrant role for the promotion of housing sector to make the government policies a success in

The DG asked the FDA officers to set the priorities for early disposal of departmental matters relating to the construction of residential and
