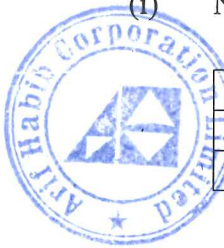
This is in continuation of our earlier disclosure made on 3rd May 2018 pursuant to section 110(1) of the Act, for acquisition of more than ten percent voting shares of ORIX Leasing Pakistan Limited (OLPL), and disclosures made on 3rd June 2019 and 18th November 2019 pursuant to Section 110(3) of the Act regarding transactions made after the expiry of period of twelve months of the acquisition notified on 3rd May 2018. In compliance of Section 110(3) of the Act, it is hereby notified that M/s. Arif Habib Limited (deemed to be person acting in concert, being subsidiary of Arif Habib Corporation Limited [the acquirer]) have acquired 316,500 shares subsequent to our previous announcement. After taking into account the shares sold subsequent to previous disclosure by the acquirer and /or persons deemed to be acting in concert, our (Arif Habib Corporation Limited [Acquirer], Arif Habib Limited [deemed to be person acting in concert] and Mr. Muhammad Arif Habib [deemed to be person acting in concert]) combined present holding in the company (OLPL) is 18,274,200 shares, which represents 10.94% of the total issued voting shares of the company (OLPL).
