

Dear Sir,

Please refer to your application dated October 26, 2020 received by this office on October 28, 2020 requesting extension till <u>June 06, 2021</u> for holding of annual general meeting (the "AGM") in terms of section 132 of the Companies Act, 2017 (the "Act"), laying therein annual audited financial statements for the year ended June 30, 2020 of Sui Southern Gas Company Limited (the "Company").

- 2. In this regard, it may be noted that the Company has failed to submit its subject application within the stipulated time of not less than thirty days before the last date on which such general meeting is required to be held as envisaged under Regulation 27 of the Companies (General Provisions and Forms) Regulations, 2018, that was September 28, 2020.
- 3. Moreover, in terms of sections 132 of the Act, listed companies can only be granted an extension of not exceeding 30 days by the Commission to hold its AGM following the stipulated time period of one hundred and twenty days after the closure of their financial year, which in the instant case would be up to November 27, 2020 as compared to requested extended timeline of June 21 2021. Further, it may be noted that a direction has already been issued on your request to the Company to hold the AGM for 2018-19 by December 10, 2020.
- 4. In connection with this, I am directed to inform you that your application for extension in time i.e. till June 06, 2021, for holding the AGM laying therein annual audited financial statements for the year ended June 30, 2020 was considered, however, the same cannot be acceded to in view of the above.


