Dear Sir,

This is with reference to your letter Ref.EMD/233/414/2002/435 dated December 30, 2020 in response to our letter Ref. ACL-4210/2157 dated December 17, 2020. In the above referred letter Company was directed to convene its overdue AGM for the year ended June 30, 2020 by March 31, 2021 and to lay therein Accounts for the year ended June 30, 2020 for shareholders' consideration and approval.

In this regard, it is apprised that the Company has filed a petition for determination of Final Revenue Requirements (FRR) for FY 2019-20with OGRA on December 18, 2020 as required under OGRA Ordinance, 2002. However, as of date, Oil and Gas Regulatory Authority (OGRA) has not been able to complete the process of finalizing Company's Final Revenue Requirements (FRR) for FY 2019-20based on which Company's Final Accounts for FY 2019-20 will be finalized and published. This matter is being continuously followed up with OGRA, however, we understand thatOGRA may not be able to finalize the Final Revenue Requirements (FRR) of the Company for FY 2019-20 within the stipulated timeframe.

Keeping in view the Company's legitimate constraints as explained above, it is requested to kindly allow to convene the Annual General Meeting of the Company for FY 2019-20 on or before May 31, 2021 for the purpose of laying of audited accounts of the Company for the year ended June 30, 2020 before the shareholders of the Company for their approval by issuance of direction under section 147 of the Companies Act, 2017.

In this regard, an Affidavit duly signed by the Managing Director and Bank Challan dated February 23, 2021 of Rs. 15,000/- (both in original), paid on account of application fee for extension in the date of holding of AGM, are enclosed.


