Dear Sir.

At the Extra Ordinary General Meeting (EOGM) of the members of the Janana De Malucho Textile Mills Ltd. (the Company) held on 13 March, 2021 at the registered office of the Company, the members of the Company, through special resolutions, have approved the Proposed Scheme of Arrangement of Merger / Amalgamation of Babri Cotton Mills Ltd. (BCML) with the Company. under Sections 279 to 285 of the Companies Act, 2017.

Members were duly apprised of the material facts regarding the Scheme as below:

- 1. The merger will be beneficial for the Company as it will lead to greater efficiency and cost synergies, i.e. by combining the business activities of both parties, performance will increase and costs will decrease and will lead to greater economies of scale. Since both companies are engaged in the business of similar goods, merging the companies will create a large opportunity to reduce costs, and will enable the Company to become more competitive.
- 2. The proposed scheme of merger/amalgamation between the Company and BCML will result in BCML being merged into the Company, with all the assets and liabilities of BCML being transferred into the Company, and the members of BCML being issued shares of the Company at the ratio of 1 share of the Company for every 1,438266 share of BCML.
