PPP to stand by ECP

Pakistan People's Par ty yesterday vowed to stand by the Election Commission of Pakistan as the government. demanded resignation of the Chief Election Commissioner Sikandar Sultan Raja and ECP members.

PPP Secretary General Syed Nayyer Hussain Bukhari said that government's demand of CEC and ECP members' resignation "is based on malafide intentions and victimisation."

Earlier in the day, the government demanded all the ECP members to quit. Federal Minister for Education Shafqat Mehmond said the ECP

had "completely failed" in fulfilling its responsibilities.

"We do not trust the Election Commission and the Chief Election Commissioner members should step down from their posts, he said. The minister said the ECP could not function in the current situation as the national institution was not playing the role of a neutral umpire.

Bukhari Nayyer strongly condomned this demand and said the "demand is laughable and beyond logic." He added: "This proves that the government wants selected institutions. This demand is an effort to pressurise the ECP. If government has any reservations then legal and constitutional remedies are available. Any institution, which is not influenced by the government, is ostracized by it."

Bukhari said the government was intentionally weakening institutions one by one. He said the "PPP stands by ECP regarding all legal and constitutional issues:

Separately, PPP Senator Palwasha Khan said it was time for Prime Minister Imran Khan and not the Election Commissioner to quit. She said the ruling Pakistan Tehrik-e-Insal leaders were wasting their time when criticizing the Pakistan Democratic Movement.

Virus scare increases chances of Parliament's virtual session

Since the third wave of coronavirus [COVID-19] is considered the most lethal, the PTTs government in consultation with opposition is multing to start virtual sittings of parliamentary bodies. As both the National

sembly Sec retariat and Senate Secretariat de cided to partially suspend all its activities in

the wake of increasing cases of corona virus especially in federal capital.

Parliamentary sources said the government. would contact the saper elements of joint opposition to take their consent for arranging virtual meetings of standing committees and special parliamentary committees.

Following the concept of digital democracy, Speaker National Assembly Asad Qaiser would once take initiative to constitute a bipartisan parliamentary

the dangerous virus. The government side has already been facing challenges to complete mandatory days of the current parliamentary year, as sessions of the National Assembly were not called due to Corona scare.

The government,

comprising three former speakers of National Assembly and other senior members jointly deliberated to amend the rules to make possible convening of an unusual session of Parliament, amid coronavirus scare. Like some other

countries, the parliamentarians of Pakistan were some steps away for witnessing a new experience due to novel disease but arguments against virtual session were considered more

sible to engage all the lawmakers to represent their constituencies in the virtual session at the same time and no MP was in favour to drop him for taking part in the virtual session of Parliament.

However, the parliamentary body could not develop consensus and regular sessions of the National Assembly and Senate were convened following SOPs. The government side has to call regular sessions of the National Assembly despite fast spreading cases of coronavirus Even the PML-N's parliamentary leader Khwaja Asif had written a letter to speaker National Assembly to complete mandatory days of parliamentary year.

It may be noted here that offices of the Secretariat had remained closed till 15th March for disinfection for Covid-19 virus. Resultantly, the meetings of National Assembly standing committees, public accounts and special committees have also been cancelled due to


