This is in continuation of our letter No. HO/CAG/SU/2021/58 dated March 04, 2021 enclosing notice of 75<sup>th</sup> Annual General Meeting of Allied Bank Limited scheduled to be held on March 25, 2021 at The Nishat Hotel, Lahore. The referred notice had already been published in newspapers and sent to shareholders on March 4, 2021.

Considering the threat posed by evolving recent wave of Corona Virus (COVID-19) pandemic, Government of Punjab, Primary and Secondary HealthCare Department vide its Notification NO. SO(G) /P&SHD/4-1/2021 dated March 13, 2021 has issued the directives imposing a complete ban on all types of indoor gatherings in Lahore; besides, Securities & Exchange Commission of Pakistan (SECP) vide its Circular No. 06 of 2021 dated March 3, 2021 has allowed the companies, which are facing practical difficulties in holding general meeting physically to hold such meeting through electronic mode.

In view of above, it has been decided to change the mode of AGM from physical to virtual to protect our shareholders from COVID-19 and to remain compliant with Government directives; accordingly, it has been decided that the meeting will be convened electronically through Zoom instead of at "The Nishat Hotel, Lahore".
