It was apprised that AGM is scheduled to be held on Friday, 26 March 2021 at 10:30 am through video-link (Zoom) with additional facility was also provided to the shareholders to physically attend the meeting at 1st Floor, 90-B/C-II, Liberty Market, Gulberg-III, Lahore.

Due to recent wave of COVID-19 pandemic, Government of Punjab vide their Notification No.SO(G)/P&SHD/4-1/2021 dated 13 March 2021 has imposed a complete ban on all types of indoor gatherings and other events.
