### STATEMENT UNDER SECTION 134(3) OF THE COMPANIES ACT, 2017

This statement sets out the material facts concerning the Special Business to be transacted at the Extraordinary General Meeting of Byco Petroleum Pakistan Limited (the "Company") to be held on Monday, 26<sup>th</sup> April 2021 at Karachi at 11:00 am.

Byco Petroleum Pakistan Limited has the biggest refining facility of 155,000 barrels per day, vertically integrated with more than 400 retail outlets across Pakistan. The refinery is also geared up with an offshore floating SPM to receive imported crude oil, finished products and also capable of exporting finished products.

Keeping in view the current dynamics of the energy business, a refinery upgrading project has been started this year. Also, the Company has plans to diversify and explore petrochemical production and investment in other aspects of energy. Being a progressive organization and to align with new vision, the Company is being rebranded from being only a petroleum refining and marketing to a chemical and energy Company as well. In line with the above, the name of the Company is being changed from 'Byco Petroleum Pakistan Limited' to 'Cinergyco PK Limited'.
