Keeping in view of the above facts and legitimate constraints of the Company, the Commission is requested to kindly grant extension for the circulation of Nine Monthly Accounts for the period ended March 31, 2021 for a period of 60 days from the date of AGM for FY 2019-20, as Half Yearly Accounts with limited scope review by the statutory auditors and 3rd Quarter Accounts shall be released simultaneously.
