APPLICATION UNDER SECTION 147 OF THE COMPANIES ACT, 2017 FOR HOLDING OF ANNUAL GENERAL MEETING AND LAYING OF ACCOUNTS THEREIN

Dear Sir,

- 1. This is with reference to your letter Ref.EMD/233/414/2002/253 dated March 08, 2021 in response to our letter Ref. ACL-4210/2195 dated February 25, 2021, allowing us to hold our overdue AGM for the year ended June 30, 2020 by May 31, 2021 and to lay therein Accounts for the year ended June 30, 2020 for shareholders' consideration and approval.
- 2. In this regard, it is apprised that Company's Tariff Regulator viz. Oil and Gas Regulatory Authority (OGRA) has not yet finalized and issued its decision in respect of the Company's Final Revenue Requirements (FRR) petition for FY 2019-20. Petition was filed in December 2020. OGRA's decision in respect of our petition for FRR is the base document which is essentially required to finalize the Company's Financial Statement, as this decision may require variousadjustments to be made in accounts which may change the financial results materially. The matter is being continuously followed up with OGRA (correspondence in this regard is enclosed As Annexure A), however, we understand that the time schedule designed for holding the AGM on May 31, 2021 after getting Final Revenue Requirements (FRR), has now been unreachable due to non-issuance of FRR by OGRA.
- 3. Based on the foregoing coupled with the worst wave of Covid-19, due to which a number of activities and staff have been restricted to 50% strength, it is requested to kindly allow SNGPL to convene the Annual General Meeting of the Company for FY 2019-20by August 15, 2021


