
Subject: Reopening of Factory & Resuming Operations of Bilal Fibers Limited

Bilal Fibers Limited has come into an agreement with the banking companies and soon a positive outlook will be reached.

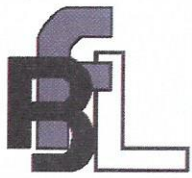
