4. Reasons for not being able to hold the AGM, or laying the balance sheet, profit & loss account at the AGM by the date mentioned in clause III and the justification for extension in the period to the extent applied for.

M/s Yousuf Adil, Chartered Accountants appointed as Company's statutory auditors on July 29, 2021 for the FY 2020-21. Now they have just concluded review of half yearly accounts for the period ended December 31, 2020 and annual Audit of accounts for FY 2020-21 is about to commence. The Auditors have given the understanding that audit will be completed once the required information / explanations have been obtained and results thereof have been addressed in the financial statements. Hence extension of 30 days is sought, so that statutory notice period of 21 days along with printing process maybe met after October 28, 2021, being the last date of holding AGM in normal course of business.

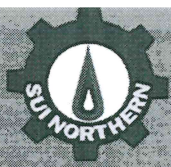



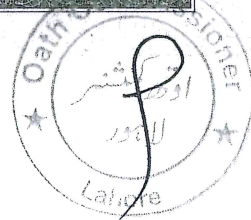
