APPLICATION FOR SEEKING EXTENSION IN HOLDING ANNUAL GENERAL MEETING AND LAYING OF AUDITED FINANCIAL STATEMENTS FOR THE YEAR ENDED JUNE 30, 2021 THEREIN UNDER SECTION 132(1) READ WITH SECTION 223(2) OF THE COMPANIES ACT, 2017 AND EXTENSION FOR SUBMISISON OF 1ST QUARTER FINANCIAL STATEMENTS FOR THE PERIOD ENDED SEPTEMBER 30, 2021 UNDER SECTION 237(1) OF THE COMPANIES ACT, 2017
