Application for Second Extension in the Period of Holding of Annual General Meeting and Laying of Accounts therein Under Section 147 of the Companies Act 2017

Dear Sir,

Please refer to our earlier letter No. ACL-4210/32 dated September 30, 2021 wherein extension was requested from SECP for holding AGM and laying of Accounts therein U/S 132 and 223 of the Companies Act, 2017.

SECP, while acknowledging practical issues being faced by our company has very kindly extended the due date, upto November 27, 2021, for holding of AGM and laying of Accounts therein U/S 132 and 223 of the Companies Act, 2017. However, it is kindly informed that till date the Company's Accounts for the year ended June 30, 2021 has not yet finalized as the audit of accounts still in progress due to which company is not in a position to submit its revenue requirement case to OGRA and the decision of the Oil and Gas Regulatory Authority (OGRA) is accordingly pending.

In view of position explained above, the Company requests for an extension, for holding of AGM and laying of Accounts therein, for 60 days from the date on which OGRA communicates the Final tariff requirement for FY 2020-21, as it is estimated that two weeks will be required to finalize accounts, arrange audit report from auditors, approval of Accounts by Board and printing of accounts, in addition to statutory requirement of 21 days prior notice to hold AGM. Accordingly in total minimum 60 days, from the date of receipt of OGRA's decision, will be required to arrange its AGM.

In this regard an Affidavit duly signed by the undersigned and Bank Challan dated October 27, 2021 of Rs. 15,000/- (both in original), paid on account of application fee for extension in the date of holding of AGM, are enclosed.

Keeping in view the Company's legitimate constraints, it is requested to kindly grant extension for holding AGM of the Company, after 60 days of the date of OGRA announcement of final tariff requirement for FY 2020-21, for the purpose of laying of audited accounts of the Company for the year ended June 30, 2021 before the shareholders of the Company for their approval.


