Bulleh Shah Packaging (Private) Limited (“**BSPL**”) is a 100% owned subsidiary of Packages Limited (“**Company**”). We have been informed by BSPL of a fire incident that occurred at its warehouse situated in Kasur at around 06:30 PM on February 9, 2022. The fire was brought under control using the in-house firefighting system and with the help of local administration. Unfortunately, two fatalities and some injuries occurred prior to the fire being controlled. The Management extends its heartfelt condolences to the bereaved/affectees. All legal procedures in respect of the incident are being strictly followed.

The cause of the accident and the extent of damage is under investigation. BSPL is also in contact with the insurance company and taking appropriate steps to ensure an early start of the repair works. There was no damage to key critical equipment and BSPL has contingency plans in place for continued supplies to its customers.
