SUBJECT: CLARIFICATION REGARDING NEWS ON MEDIA AS PER RULE NO. 5.6.2 OF PSX RULES

Dear Sir,

This information is drafted for dissemination for the Pakistan Stock Exchange amongst the investors and public in accordance with Rule 5.6.2 of PSX Rules for clarifying news circulated on media regarding recovery of Sales Tax.

Large Taxpayer Office (LTO) issued Notice of recovery of Sales Tax to banks regarding SSGC without following the legal process and waiting for decision of an independent Forum i.e., Appellate Tribunal. Demand was raised on irrational and unreasonable grounds of treating swapping of indigenous gas against RLNG to SNGPL as Sales Income.

Against the said recovery Notice, SSGC filed Constitutional Petition before Sindh High Court (SHC) and the SHC suspended the recovery notice of LTO through an Order dated 23-02-2022 (Annex-A) being devoid of legal merits and directed SSGC to pursue matter before the Appellate Tribunal.

Consequently, LTO withdrawn the said Notice with immediate effect (Refer Annex-B).

- 1] Urgency granted.
- 2] Exemption granted subject to all just exceptions.

After arguing the matter at some length, learned counsel for the Petitioner submits that the Petitioner would be satisfied and not press this petition if the Impugned Demand Notice sent to all the Banks dated 22-02-2022 bearing No.DCIR/U-4/Enforcement-II/LTO/2021-22/897, available at Page No.27, Annexure 'B', be suspended by permitting the Petitioner to file an urgent appeal in accordance with law before the competent forum, for which a total period of 60 days is available. Learned counsel for the Petitioner as well as legal representative of SSGC nonetheless unreservedly undertake that the latter would proceed with filing of the said appeal within next seven [7] days at most, however, requests that whilst substantial time to file the appeal is still available as per law and whereas the requirement of Rule 71(1) seemingly has not been complied with, operation of the Impugned Demand Notice be suspended till such period of seven days least to say. Counsel has heavily placed reliance on the paragraphs 6 and 7 of the case reported as 2020 PTD 165 (Quaid-e-Azam Thermal Private Limited versus Federal Board of Revenue and others).

In the given circumstances, the request made by the Petitioner is granted and the petition in hand is accordingly disposed of alongwith the stay application with the direction to the Petitioner to file appropriate appeal in accordance with law before the competent forum within Seven [07] days and press his grievance before them, however, in the meanwhile, operation of the Impugned Demand Notice shall remain suspended for this period. The funds attached in consequence of the afore-noted Impugned Demand Notice shall not to be withdrawn or transferred by the respondent within this seven [07] days period too.

This order shall seize to hold its effect after expiry of seven [07] days from today i.e. on 03-03-2022.
