

4&5. The Executive Director, Supervision Division, SECP passed order dated 27.05.2022 under Section 257 of the Companies Act, 2017 for investigation into the affairs of the Appellant/Company. The Appellant preferred an appeal under Section 33 of the SECP Act, 1997 before the Appellate Bench of the Commission; however, the Deputy Registrar of the Appellate Bench was not inclined to register the appeal on the ground that such an appeal was barred by provisos (a) and (d) of Section 33(1) of the SECP Act, 1997 viz. that an administrative direction given by a Commissioner or an interim order is not appealable. Against such refusal, the Appellant is before this Court with an appeal under Section 34 of the SECP Act, 1997. Learned counsel submits that provisos (a) and (d) of Section 33(1) of the SECP Act are not attracted and hence the appeal against an order of investigation is appealable before the Appellate Bench of the Commission. As regards the appeal before this Court against the order of the Deputy Registrar of the Appellate Bench refusing to register the appeal, learned counsel relies upon an order dated 08.03.2022 passed by a learned Single Judge of this Court in Suit No.



329 of 2002 to submit that the order of the Deputy Registrar of the Appellate Bench can be treated as an order of the Appellate Bench itself. He prays that in the meanwhile since the investigators appointed by the SECP are at the door steps of the Appellant, interim orders may be passed.

Issue notice to the Respondent for 28.06.2022 at 11:30 a.m. Till the next date, the investigation into the affairs of the Appellant/Company shall remain stayed. At this juncture, Syed Imran Ali Shamsi, Law Officer of the SECP enters appearance,

vaives notice and claims copy. Learned counsel for the Appellant

virgiertakes to provide the same.
