Economic activities in the country, the meeting discussed CPEC projects related to IT and Telecom. Broadband Services in un-served areas to provide digital solutions on micro level.

Matters related to IT and Telecom Industry and proposals from the stockholders discussed deeply to enhance the digital economy of Pakistan by identifying the key areas of growth, their challenges and way forward to overcome the challenges.

On Data Protection Law Member IT Syed Junaid Imam and Member Legal Babar Sohail, while Mem-

Further, she said that the apex court's order cleared that no proof of foreign interference was presented before the court. "The court has held that it is not clear that if it was such a serious matter, why did the prime minister at the time, Imran Khan, not ordered an inquiry into the matter and instead adopted silence," she said.

She said that it was decided that a special committee has been formed, led by Federal Law Minister Nazir Tarar, and federal ministers of interior, information and others to review the points contained in the order and prepare a set of recommendations on implementing them.

The information minister said the cabinet, which met with Prime Minister Shehbaz Sharif in the chair, welcomed the Supreme Court's detailed judgment. On April 3, before voting could commence against Imran Khan, Qasim Suri dismissed the vote, describing it as "unconstitutional" and backed by "foreign powers".

According to a statement issued by the ISPR, on Friday, during the ongoing security operation Ziarat encounter started before July 14 and 15 (Thursday and Friday) a hideout of terrorists was identified and cleared by the security forces near Khost in Khyber Pakhtunkhwa.

Once encircled, the terrorists opened fire on the closing-in Army troops resulting in Shahdad (martyrdom) of Havildar Khan Muhammad.

During follow-up clearance operation, the ISPR statement said five terrorists belonging to Baloch Liberation Army were killed in ensuing heavy exchange of fire.

The sanitization operation, however, will continue in the area to ap-

prehend remaining perpetrators and recover Mr Omar Javed.

Meanwhile, Prime Minister Shehbaz Sharif on Friday paid tribute to the martyred Lt-Col Laiq Baig, saying that the officers and jawans of the Pakistan Army were rendering great sacrifices for the motherland.

The prime minister said the sacrifice of Lt-Col Laiq Baig would not go in vain and the terrorists would be taken to task. He said the entire nation was determined to eliminate terrorism from the country.

PM Sharif extended condolences to the family of Lt-Col Laiq Baig and prayed for the departed soul of the martyred to rest in peace. President Dr Arif Alvi also expressed grief and sorrow over the martyrdom of Lt-Col Laiq Baig Mirza.

down high costs of gasoline and ease the highest US inflation in four decades. The White House said Biden would hold a bilateral meeting with Saudi King Salman bin Abdulaziz at the royal palace in Jeddah and then the president and his team would have a working session with Crown Prince Mohammed bin Salman and Saudi ministers at the palace.

Meanwhile, Joe Biden said during

a trip to the occupied West Bank on Friday that Palestinians need to see a path towards statehood and that "there is hope for a peace process with Israel and a bright future". Biden's visit to Bethlehem came after a flight to Saudi Arabia whose leaders on Friday changed aviation rules in an apparent gesture of openness towards Israel.

The president's visit to the Saudi city of Jeddah will follow talks with

Abbas, the latest high-level diplomatic meeting after those with the Israeli leadership on Thursday.

Biden reiterated his administration's commitment to a two-state solution to end the Israeli-Palestinian conflict, saying there "must be a political horizon that the Palestinian people can actually see".

"I know that the goal of the two states seems so far away," he said in Bethlehem, alongside Abbas.

The Palestinian president said he was "taking steps" to improve the bilateral relationship and aimed to see the US return to Palestine's recognition of Jerusalem, which was shattered by Trump. "The last year has brought recognizing the state of Palestine," Abbas said. With Israeli-Palestinian peace negotiations moribund since 2014, the US delegation has been focusing on economic measures.
