This is with reference to section 132 & 223 of the Companies Act 2017, wherein company requires holdingAnnual General Meeting of the Company within 120 days following the close of its financial year.

In this regard, this is to apprise that review of Half Yearly accounts for FY 2021-22 has just concluded and auditors have issued draft review report and will issue final review report shortly. The audit of the twelve months Accounts has also commenced. Non-completion of audit has necessitated this application under sections 132& 223 of the Companies Act 2017 seeking extension for 30 days in holding the Annual General Meeting of the Company and laying of accounts therein.

The Annual General Meeting of the Shareholders of the Company is required to be held on October 28, 2022 and the

sheet and profit and loss account and reports relating to accounts are required to laid at such meeting.

Audited Accounts for the Year ended June 30, 2022 are required to be laid down before the Shareholders.

4. Reasons for not being able to hold the AGM, or laying the balance sheet, profit & loss account at the AGM by the date mentioned in clause III and the justification for extension in the period to the extent applied for.

M/s Yousuf Adil, Chartered Accountants appointed as Company's auditors on July 29, 2022 for the FY 2021-22. Now they have just concluded review of half yearly accounts for the period ended December 31, 2021 and annual Audit of accounts for FY 2021-22 has commenced. The audit of the Accounts could not be completed till September 29, 2022. The Auditors have given the understanding that audit will be completed once the required information / explanations have been obtained and results thereof have been addressed in the financial statements. Hence extension of 30 days is sought, so that statutory notice period of 21 days along with printing process maybe met after October 28. 2022, being the last date of holding AGM in normal course of business.




