Dear Sir,

Please refer to our letter No. ACC-501-006-22 dated October 13, 2022 and your approval letter No.SMD/PRDD/Comp/(13)/2021/351 dated October 20, 2022 granting us 30 days extension i.e up to November 29, 2022 to submit accounts for the quarter ended September 30, 2022 under the provisions of Section 237 of the Companies Act, 2017.

We further refer to our letter No. ACC-501-007-22 dated November 01, 2022 where in, the Company has requested the commission to grant extension for holding AGM of the Company, on or before April 15, 2023, for the purpose of laying of audited accounts of the Company for the year ended June 30, 2022 before the shareholders of the company for their approval.

SECP and IAS-34 (Interim Financial Reporting) require that interim reports shall include interim financial statements (condensed or complete) and comparative figures of immediately preceding financial year be mentioned at appropriate place, which in our case are provisional and unaudited till date. In this respect, it is apprised that the audit of accounts for FY 2021-22 has not yet been completed and upon completion of audit the company will file the Final Revenue Requirement (FRR) with OGRA, after which the Financial Statements will be finalized by incorporating the decision of Oil and Gas Regulatory Authority (OGRA) with respect to the FRR.

In the absence of FRR for FY 2021-22 and approval of Financial statements from Company's BOD, the opening balance sheet figures for 1st quarter ended September 30, 2022 would be based on provisional figures which can materially change, once the Final Revenue Requirements are finalized by OGRA. Accordingly, the opening audited balances for the FY 2022-23 for preparation of 1st quarterly accounts i.e. September 30, 2022 would be available after the Financial Statements for the year ended June 30, 2022 are approved by BOD and disseminated to Pakistan Stock Exchange (PSX) and other stakeholders.

As explained above and keeping in view of the peculiar circumstances of the Company, you are further requested to please grant us extension in the period for circulation of quarterly accounts of the Company for the quarter ended September 30, 2022, <u>for a period of 30 days from the date of approval and Authorization of Annual Accounts of the Company for FY 2021-22 by the Board of Directors of the Company</u>, please
