C.M. No.1/2023

This is an application to place on record certain documents. Subject to all just and legal exceptions, the application is allowed and the documents are placed on record.

C.M. No.2 & 5 of 2022 and main case.

This winding up petition under Section 305 read with section 309 of the Companies Ordinance, 1984 (Ordinance) was filed by petitioner (SECP) against the respondent No.1 (Company). The petition was allowed by this Court on 08.03.2022 mainly on the ground that respondent's company failed to fulfill statutory requirement of Ordinance and Companies Act, 2017 (Act). However, after the winding up order, the shareholders of the company in their meeting dated 10.08.2022 with 60.12% of shareholding unanimously approved the scheme of arrangement. Resultantly, C.M. No.2/2022 has been filed by the learned Official Liquidator and C.M. No.5/2022 has been filed by the contributors to recall winding up order dated 08.03.2022 under Section 313 of the Act read with Rule 3 of the Companies (Court) Rules, 1997 (Rules).

- 2. Learned counsel for the SECP has filed replies of C.M. No.2 & 5 of 2022 and submits that SECP has no objection for revival of the company after recalling of winding up order, if all regulatory requirements are fulfilled by Company. In response, contributors of Company have filed C.M. No.1/2023 placing on record undertaking by the contributors as well as Company Secretary of the respondent's company for fulfilling statutory requirements. In view of above undertakings, learned counsel for SECP has no objection for recalling of the winding up order and disposing of the winding up petition. However, submits that if statutory requirement will not be fulfilled by the Company, SECP will be at liberty to approach this Court afresh through appropriate proceedings. This is also acceptable to the learned counsel for the contributors as well as learned Official Liquidator.
- 3. In view of above consensus developed between the learned counsel for the parties, C.M. No.2 & 5 of 2022 are allowed in above terms and after recalling the winding up order dated 08.03.2022, the respondent-Company is revived and main winding up petition is **disposed of** accordingly.

PETITION UNDER SECTION 305 READ WITH SECTION 309 OF THE COMPANIES ORDINANCE, 1984, READ WITH ALL OTHER ENABLING PROVISIONS OF LAW FOR WINDING UP OF RESPONDENT NO. 1

(M/s Data Textile Limited)

Respectfully Sheweth:-

- 1. That the names and addresses of the parties as given in the title of the Petition are true and correct as per the record maintained by the office of the Petitioner and the same are sufficient for the purposes of effecting service upon them.
- 2. That the Petitioner is an officer of the Securities & Exchange Commission of Pakistan ("SECP") established under the Securities and Exchange Commission of Pakistan Act, 1997 for, inter alia, the superintendence and control of corporate entities and for matters connected therewith and incidental thereto. The Petitioner, being the Additional Registrar of Companies and Incharge Companies Registration Office, Lahore, SECP is fully conversant with the facts of the instant Petition and is duly authorized under Section 309(b) of the Companies Ordinance, 1984 (the "Ordinance") to present this Petition before this Hon'ble Court after taking due sanction in this behalf.

- 7. That additional grounds may kindly be allowed to be raised during the proceedings of the petition.
- 12. That in view of the above it is therefore in the interest of justice and equity that the Respondent Company (i.e. M/s Data Textile Limited) is wound-up.

PRAYER:

It is, therefore, most respectfully prayed that this Honourable Court may be pleased:

- A. to order the Winding-Up of the Respondent Company (i.e. M/s Data Textile Limited) under the provisions of the Companies Ordinance, 1984;
- B. to appoint Official Liquidator/the provisional manager may please be appointed to conduct the winding-up proceedings and perform related duties directed to record the statement of affair of the company within the contemplation of Section 328 of the Companies Ordinance 1984;
- C. to order appropriate proceedings against the Chief executive and directors may also be initiated; and
- D. to pass such further order or orders and to issue all consequential and necessary directions as this Honourable Court may deem fit and proper in the circumstances.

Any other relief which this Hounarable Court deems fit and proper in the peculiar circumstances of the instant petition may very kindly be awarded.
