In accordance with Section 96 and 131 of the Securities Act 2015 and Clause 5.6.1 (a) of PSX Regulations, Indus Motor Company Limited ("Company") hereby conveys the following material information:

The Company and its vendors continue to face hurdles on import of raw materials and receiving clearance of their consignments from commercial banks, on account of difficulties in opening of LCs for raw materials by banks. This has disrupted the supply chain of the company and its vendors are unable to supply raw materials and components to the Company.

Accordingly, the company has insufficient inventory levels to maintain production, therefore the company is unable to continue its production activities.

In view of the above, the Company has decided to completely shut down its Production plant from **2nd May 2023 to 3rd May 2023** (both days inclusive).
