CONVERSION OF CLASS B ORDINARY SHARES WITH AND INTO ORDINARY SHARES

The shareholders of Class B Ordinary shares of Ghani Chemical Industries Limited (GCIL/the Company) are hereby informed that in compliance with approval of the shareholders of the Company in their Extraordinary General Meeting dated April 17, 2023 for conversion of Class B Ordinary shares of GCIL with and into Ordinary shares of the Company at the ratio of 1:1, the Board of Directors of GCIL in their meeting held on April 29, 2023 has decided as under:-

- For determining the entitlement of Ordinary shares of GCIL to the shareholders of Class B Ordinary shares, the Share Transfer Books of the Company will remain closed from Wednesday, May 17, 2023 to Friday, May 19, 2023 (both days inclusive).
- Trading in the shares of GCIL Class B Ordinary shares at Pakistan Stock Exchange Limited (PSX) will be suspended w.e.f. May 16, 2023. Thereafter, shareholders of GCIL Class B Ordinary shares shall surrender their share certificates for conversion thereof to GCIL Ordinary shares.
- After conversion of GCIL Class B Ordinary shares with and into Ordinary shares of GCIL, Class B Ordinary shares shall be de-listed from the Pakistan Stock Exchange Limited (PSX) and also deleted from the list of eligible security in the Central Depository System (CDS).
