## 1. Closure of Share Transfer Books.

# 2. Participation in General Meeting

A member entitled to attend and vote at the meeting, may appoint another person as his/her proxy to attend, speak and vote instead of him/her. Proxies, in order to be effective, must be received at the Registered Office not less than 48 hours before the time for holding the meeting.

CDC shareholders entitled to attend and vote at the meeting must bring his/her participant ID and Account/sub-account number along with original CNIC or original passport to authenticate his/her indemnity. In case of corporate entity, resolution of Board of Directors/power of attorney with specimen signature of nominee along with his/her recent photograph shall be produced (unless it has been provided earlier) at the time of the meeting.

#### 3. Change in Address and CNIC

Members are requested to notify/submit information for change of their address if any and provide valid CNIC duly attested.

#### 6. Deposit of Physical Shares into CDC Account

As per Section 72 of the Companies Act, 2017 every listed company shall be required to replace its physical shares with book-entry form in a manner as may be specified and from the date notified by the commission, within a period not exceeding four years from the date of the promulgation of the Companies Act, 2017.
