Extract from Pak-Gulf Leasing Company Limited (PGL) Board of Directors 173<sup>rd</sup> meeting held on June 8, 2023 Declaring cash dividend and issue of Bonus Shares

**Resolved that:** An interim cash dividend of Rs 3.50 per share i.e. at the rate of 35 percent to be paid to the shareholders for the year ending June 30, 2023 out of the unappropriated profits of the Company;

Transfers received in order at the office of the Registrar of PGL – THK Associates (Pvt) Ltd before the close of business hours on Thursday, June 15, 2023 will be treated as in time for the purpose of entitlement to the dividend to the transferees;

**Further Resolved that:** The Board authorizes the Chief Executive Officer or the Company Secretary to perform all formalities in connection with the payment of interim cash dividend and issuance and allotment of the bonus issue.
