Our verification was limited to checking from the supporting documents and account statement that net amount of Rs. 3,202,533,048 which includes outstanding principal amount and accrued profit thereon after the deduction of zakat and tax as per applicable laws has been repaid to the holder of TFCs as of the date of final book closure on 20 December 2022. However, an amount of Rs. 14,046 which includes outstanding principal amount and accrued profit thereon after the deduction of zakat and tax as per applicable laws still remains unclaimed with the Bank. Furthermore, the certificate is only limited to the facts disclosed and is not certificate of assurance.
