This is a case of compulsory liquidation of the Company under the order of Lahore High Court Lahore dated 13-07-2017 which was reversed on 29-10-2021 by the said court and assets were handed over to the management only in November 2021.

On completion of audit for the year ended 30-06-2021 and 30-06-2022 and after its approval from Board of Directors, the management of the company intends to hold AGMs on 30-11-2023 for the year 2021 and 2022 u/s 147 of Companies Act, 2017 for approval of Audited Accounts for those years.

You are requested to grant permission to hold AGMs by 30-11-2023 for the years 2021 and 2022.
