For the purposes of election of directors of the Company, the voting shall be held separately in the following three (3) categories:
 - i. Female Director
 - ii. Independent Director(s)
 - iii. Other Directors

A member in their discretion may cast vote to any candidate contesting election in each of the above categories. It must, however, be noted that division of votes available to each member for a category shall be in proportion to the number of seats of directors under such category. If the number of members who offer themselves in each category is not more than the number of directors to be elected in each category, such members will be elected unopposed without the voting process.
