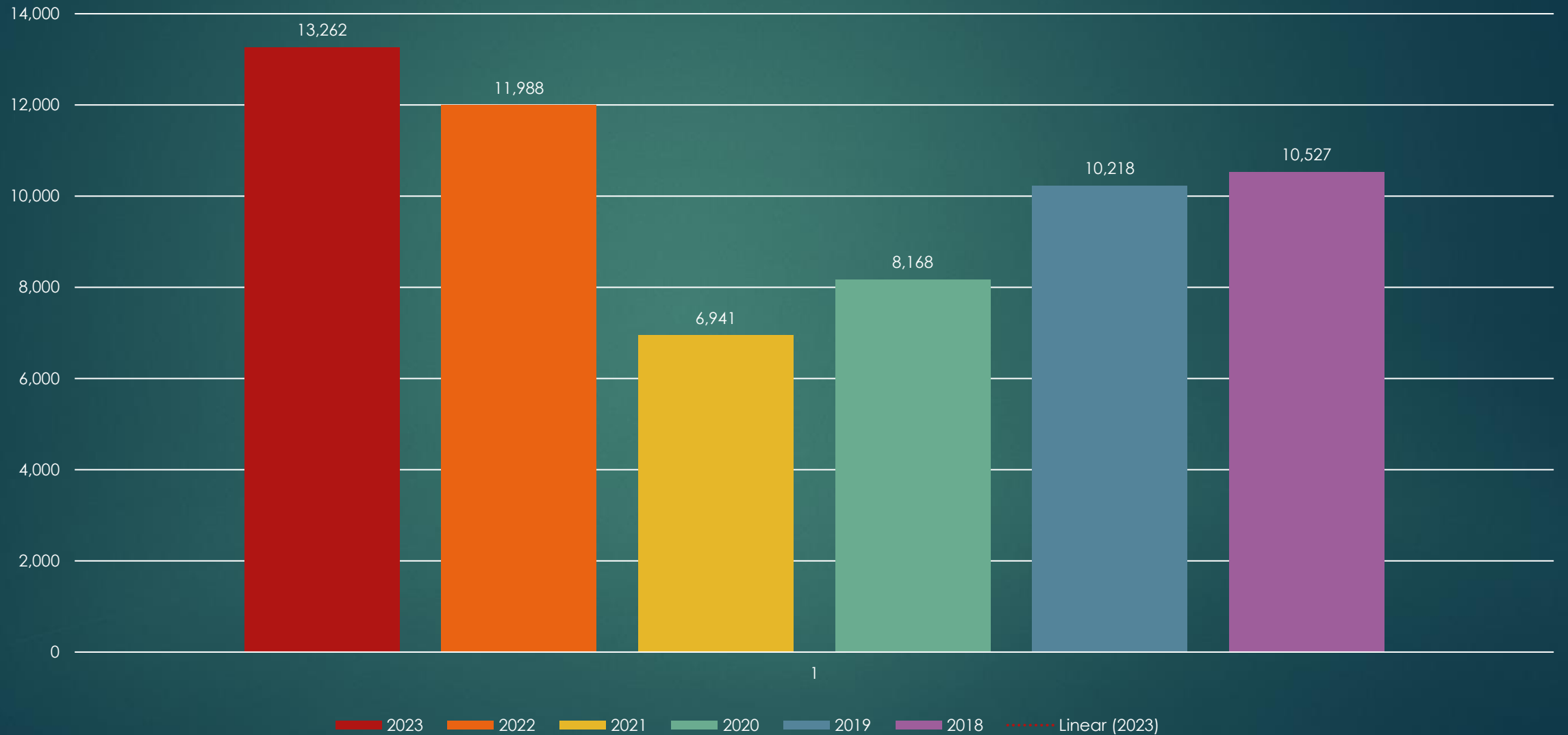

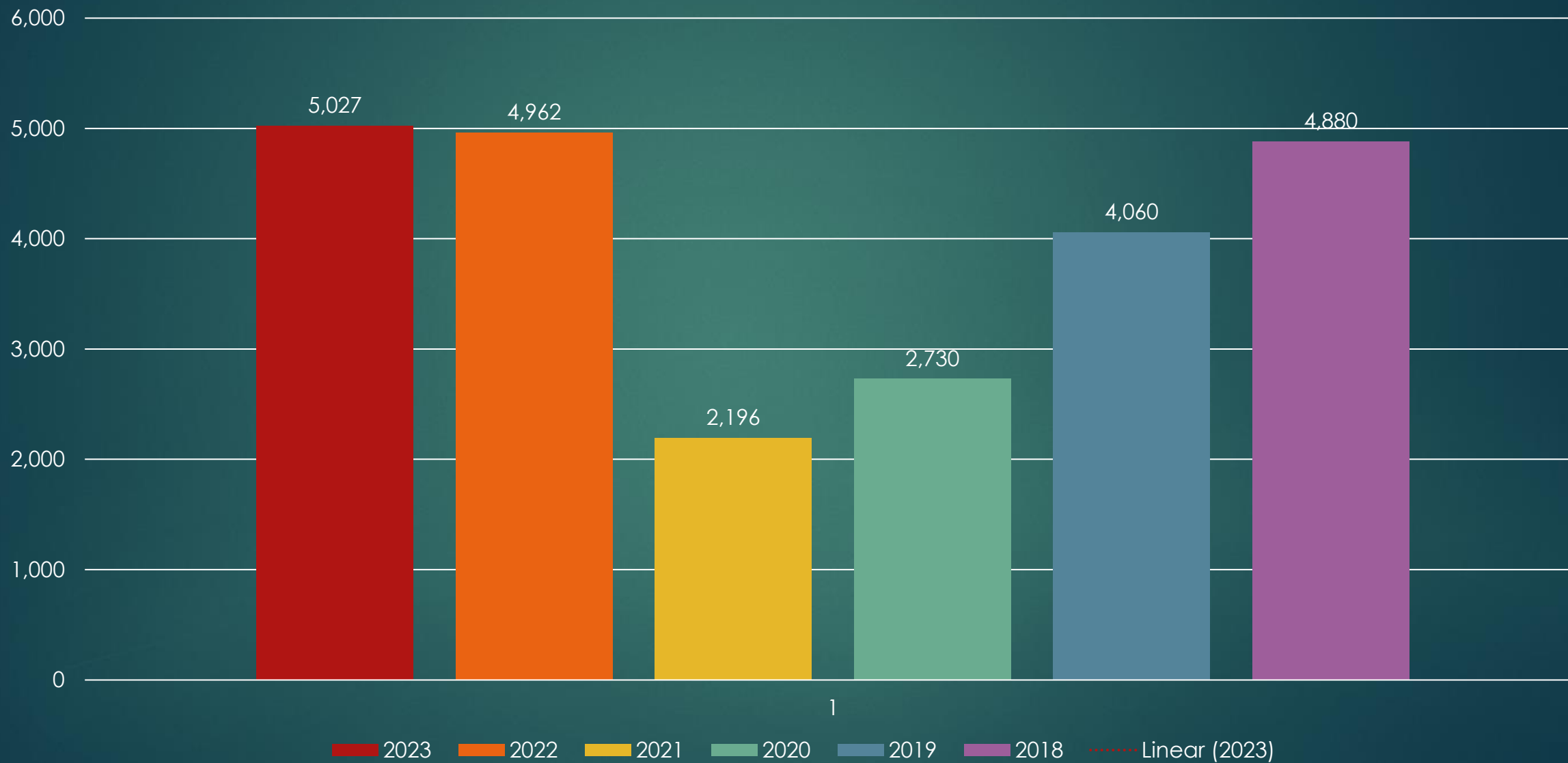

NET REVENUE (RUPEES IN MILLION)



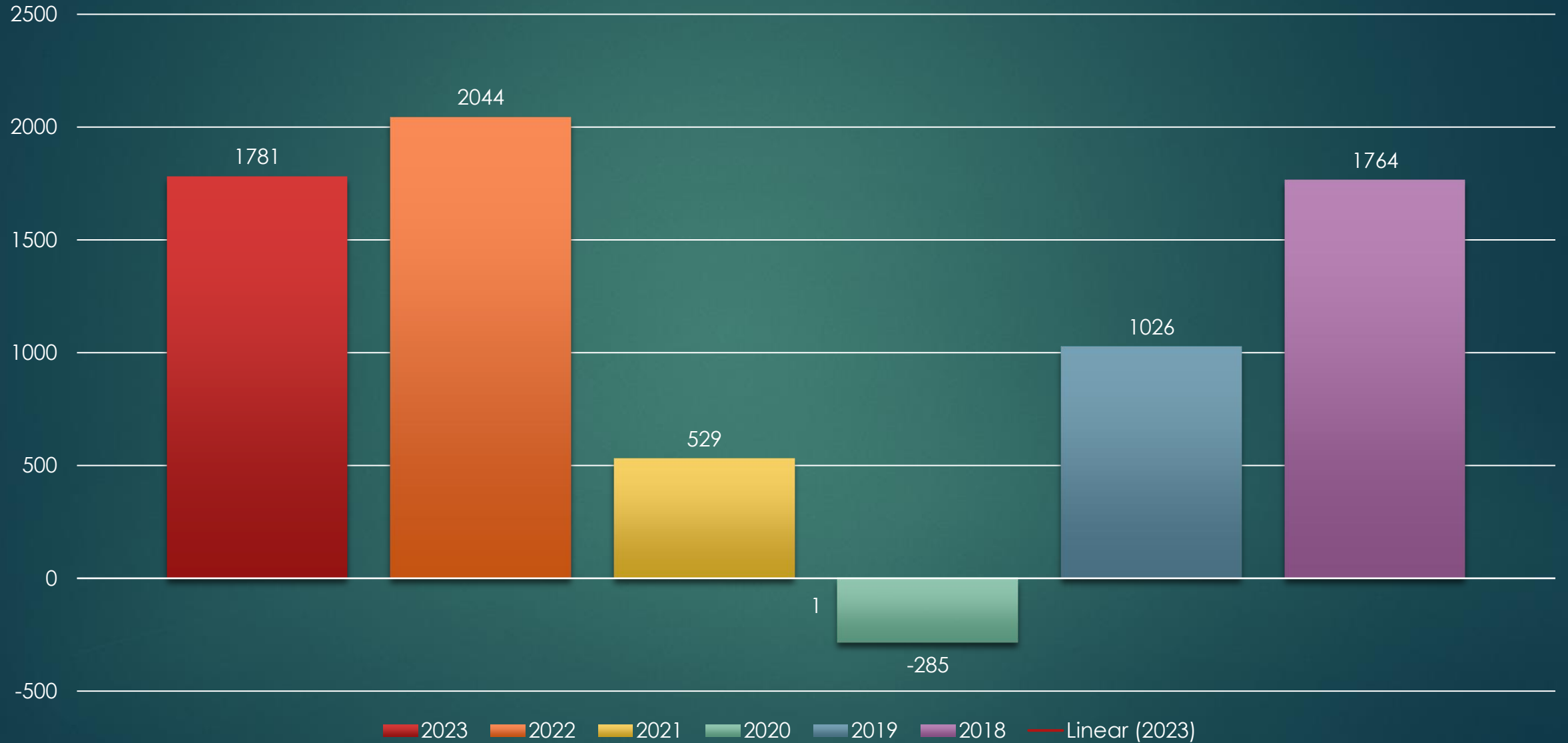

GROSS PROFIT (RUPEES IN MILLION)



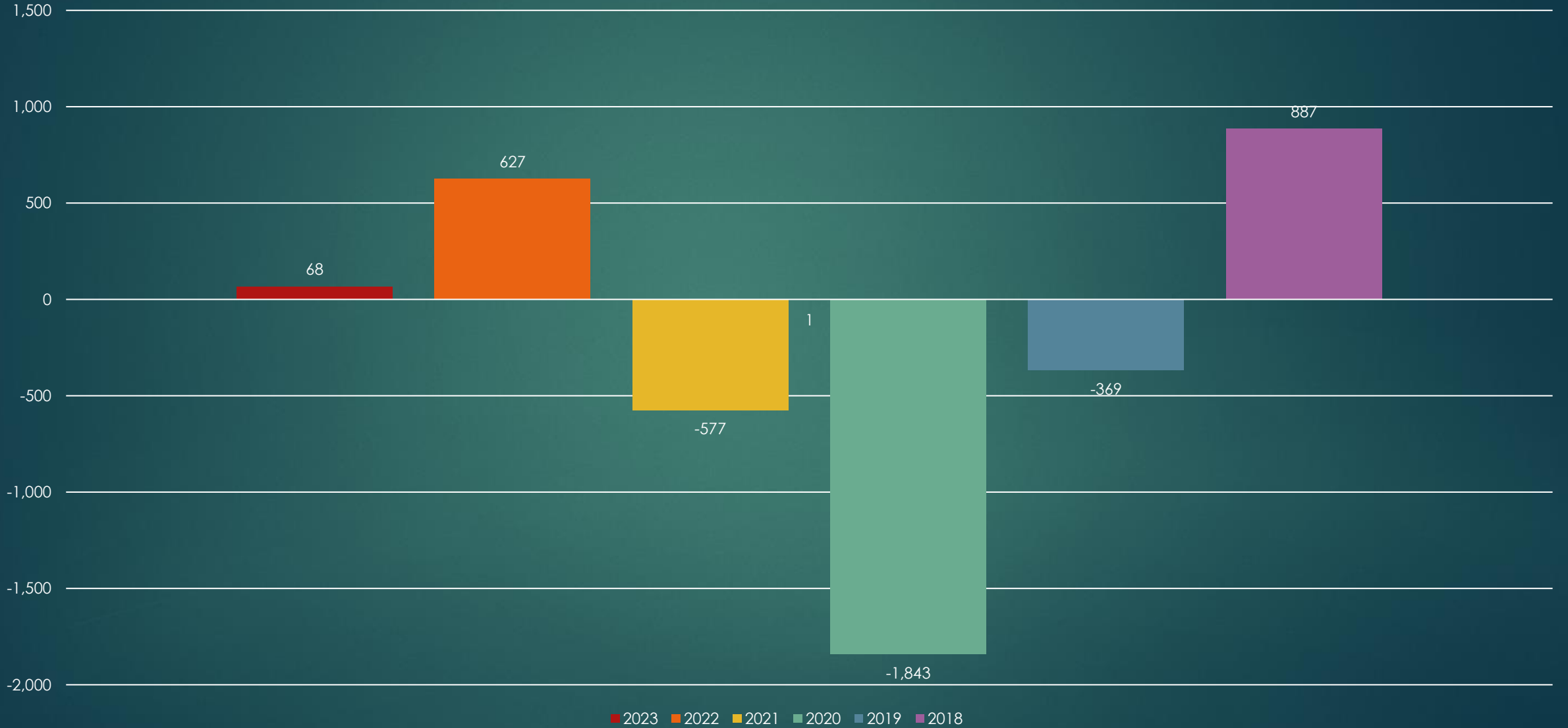
