Update on Pre-Qualification Status in Privatization Process of Pakistan

Further to our earlier disclosure dated 9th May 2024, we wish to provide an update regarding Arif Habib Corporation Limited's (AHCL) participation in the privatization process of the stateowned Pakistan International Airlines (PIA).

We are pleased to inform you that in accordance with Press Release # 16 / 2024 available at the website of Privatization Commission (PC), AHCL has been pre-qualified to participate in the bidding process for PIA. Additionally, as reported in the subject Press Release, five other companies/consortia have also been selected as pre-qualified bidders.

As mentioned in our previous disclosure, pre-qualified bidders who opt to advance further in the process will now commence the due diligence process before making final bids. AHCL's further participation in this process will depend on the outcomes of the due diligence and the subsequent guidance from our Board of Directors regarding the future course of action.

We would like to reiterate that AHCL operates as an investment holding company, with a primary focus on strategic investments in subsidiary companies and associates across various sectors. Evaluating investment proposals, such as this, is a routine aspect of our business operations.
