DECLARATION OF FINAL CASH DIVIDEND 53(F)

The Board of Directors of Security Papers Limited in its meeting held on July 30, 2024 has declared Final Cash Dividend 53(F) at the rate of Rs 10.00 per share i.e., 100% for the year ended June 30, 2024. This is in addition to the interim cash dividend already paid at the rate of Rs 2.50 per share i.e. 25% making a total of Rs 12.50 per share i.e. 125%. The dividend will be paid to those shareholders whose names appear in the Register of members at the close of business on September 18, 2024.

The Share Transfer Books of the Company will remain closed from September 19, 2024 to September 25, 2024 (both days inclusive).

Payment of Cash Dividend Electronically (e-Dividend Mechanism)
