
The Auditors have expressed adverse opinion on going concern assumption used in preparation of financial statements and non-revaluation of property plant and equipment with sufficient regularity.

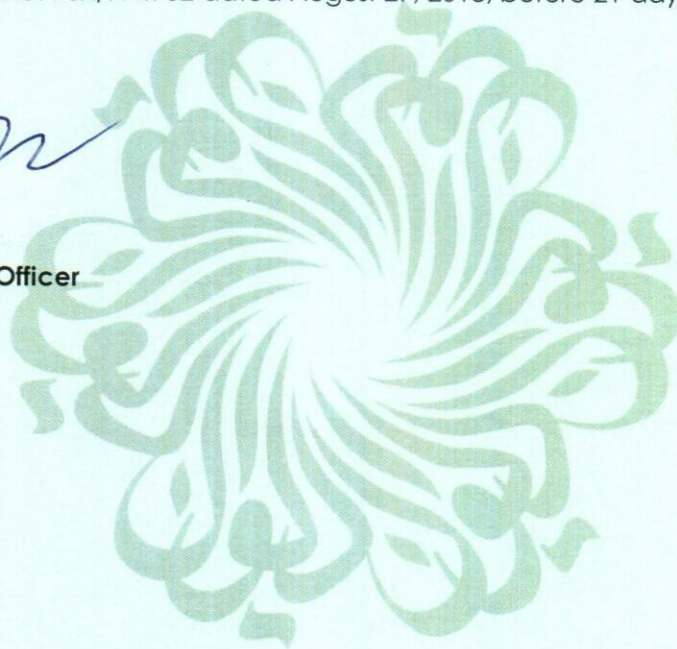
